

WINTER PARKS

Winter is homeless and was last seen hanging around the Day Center, 400 W. Archer Street, and other homeless shelters. Winter is deaf. She may also be using the alias of Avalina Caldwell or Angel Rose. Winter has been missing since March of 2009.



Toni Long, also known by her maiden name of Toni Cooley, was last seen on May 20, 2011 at her residence near West 23<sup>rd</sup> Street and Southwest Blvd. Toni has not made any contact with her family or friends since this date. She has young children and her disappearance is unexplained. Toni is 30 years old and has a distinctive tattoo on her left lower leg.



JASON ARMSTRONG

Jason Armstrong was reported missing by his family in 2004. His Mother stated he made a phone call to his Grandmother in August 2000 saying he was in trouble and was never seen again. Jason has a tattoo of a gun on his arm.



**ALTHEDIA VAUGHT** 

On January 19, 2009 the victim, Althedia Vaught, left her residence in the area of 3600 S. New Haven Avenue. She left her residence in her vehicle dressed only in her night clothing/sleep wear. On January 24, 2009 Althedia Vaught's vehicle was located in the Hillcrest Hospital parking lot. The vehicle was abandoned and there was no sign of Ms. Vaught.

Detectives reviewed surveillance footage from the security cameras and discovered when Althedia Vaught's vehicle was driven into the parking lot.

Additional surveillance footage revealed that prior to the victim's vehicle being driven into the parking lot, a white 2003 Chevrolet extended cab truck was driven into the parking lot by a black male who was later identified and interviewed.

Detectives need any information the public could provide regarding the disappearance of Ms. Vaught.

MARK INHOFFE

Mark Inhoffe, a 51 year old male, was last contacted on May 26, 2009 when he cashed a check at a financial center at Pine Street and Cincinnati Avenue, which was his monthly routine. Mark Inhoffe lives a transient lifestyle with a history of staying in the downtown area of Tulsa. Since May 26, 2009there has been no confirmed contact or sighting of Mark Inhoffe. Family members are concerned about his well being.



#### THOMAS MARTIN

71 year old Thomas Martin is missing from his residence at 5300 West 11<sup>th</sup> Place. He disappeared between June 27, 2010 and June 30, 2010. His vehicle was located at his residence, but the investigation indicates it may have been driven and returned by someone other than Martin.

Detectives need any information from anyone who saw Martin's vehicle, a white 2010 Honda Fit, being driven in Tulsa or on the Oklahoma Turnpike system in the last days of June 2010.

#### KATHLEEN HENSON ROYCE HENSON

Kathleen Henson and her 17 month old son Royce Henson were last contacted on May 23<sup>rd</sup>, 1979. Ms. Henson was en route to the home of a friend and did not show up. On May 25<sup>th</sup>, 1979 her vehicle was found at the corner or Ute Street and Peoria Avenue. Ms. Henson worked for a record shop on North Peoria Avenue.



Information received during the investigation indicated Kathleen may have met with foul play, but that it is possible Royce was given to someone and raised without knowledge of his true identity. This is an age progressed image of what Royce may look like today.



# MARISELA LEMUS CORTES MATTHEW OLIVER CORTES

Marisela Lemus Cortes, then a 31 year old Hispanic female, and her son, then a 4 year old Matthew Oliver Cortes, were last seen in October of 2000. Originally reported a Missing Persons, investigation indicates Marisela left the area with Matthew Cortes in an attempt to hide the child from his natural Father. Marisela Cortes has an outstanding Felony Warrant for Child Stealing.

Richard Rounsaville was last contacted in January 1996 at which time he told his family he was living in Tulsa near a hospital and was preparing to get his own apartment. The victim has a history of mental health problems and was reported missing by his family when they could not locate him. He has not been found.



Billy Storkson was last contacted on October 22<sup>nd</sup>, 1991 at approximately 3:00 A.M. when he called several friends and family members. His location at the time of his call is believed to have been Carl's Lounge, 1100 S Denver Ave. Storkson has never been located.
